Information

- * **Basic Skills Taskforce – Update/M. Parsons**
 - M. Parsons informed the committee an SDCCD taskforce has been organized with the goal of creating an overview by May 2016 of what the three colleges, District and Continuing Education are doing in the area of Basic Skills success and to make recommendations to improve success.
- * **C-ID MATH 119 – Update/M. Parsons**
 - The committee was informed by M. Parsons Mesa's MATH 119 with its prerequisite has been accepted at the state level and a new C-ID MATH 111 which will have a prerequisite will be put into the C-ID system. Mesa will resubmit MATH 119 for the new C-ID MATH 111.
- * **HIMS Baccalaureate Degree/Draft Handbook – Handout/Discussion**
 - R. Fremland, S. Hess and M. Parsons were in Sacramento to meet with other colleges that have pilot baccalaureate degrees. M. Parsons reported that Mesa is ahead of the curve in implementing baccalaureate degrees and thanked the committee for their work on reviewing and approving the new curriculum needed for Mesa's degree.
 - At the Sacramento meeting it was decided that rather than make a change to Title V for a possibly temporary item it was opted to create a handbook.
 - M. Parsons requested members to email her with any comments/questions they may have upon their review of the draft handbook.
- * **Mesa Academic Senate Constitution – Handout/Discussion**
 - The committee reviewed the Curriculum Committee portion of the constitution with the notations the term limit for chair was adjusted to two years and it now states that of the three deans on the committee one would be from the CTE area.
 - Several suggestions to define/clarify other members of the committee were given.
 - If members have other suggestions/recommendations M. Parsons requested they be emailed to her and she will submit all of the changes to the Academic Senate.
