- * **Mesa Academic Senate Constitution – Update**
 - R. Fremland informed the committee the revised Academic Senate constitution is in its final stages and the recommendations from the committee for the curriculum section have been incorporated into it.
 - An electronic copy of the constitution should be available for everyone's review sometime after Friday, March 4, 2016.
- * **ENGL 031/ENGL 101 – Update**
 - M. Parsons informed the committee the ENGL 031 proposal at first was not approved by CIC.
 - After much discussion and Mesa faculty agreeing to adjust ENGL 101 to have ENGL 031 listed as an "or" corequisite on ENGL 101 CIC approved both ENGL 031 and the revised ENGL 101.
 - ENGL 031 will be taught with ENGL 101 as a Learning Community.
- * **Effective Practices/Alignment Draft – Handout**
 - M. Parsons discussed the draft Effective Practices/Alignment document with the committee and pointed out several issues of having SDCCD aligned curriculum.
 - The committee was asked to review the document further and bring back to the committee any thoughts or concerns about effective practices and/or alignment the handout elicited.

- * Courses Active Not Offered Report – Handout
 - M. Parsons shared with the committee an electronic copy of Mesa’s courses which are active but have not been offered in the last four semesters.
 - It was noted that some of the courses listed have been agreed to not be offered at Mesa as one of the other colleges offers it for all colleges in order to have enough students enrolled.
