- A. Position Paper #6 (Reassigned Time): Approved by the Senate & President's Cabinet in March 2009.
 - 1. The paper provides a process for Academic Affairs to review requests for reassigned time.
 - a. Academic Affairs heard reports and made recommendations to President's Cabinet in the past.
 - b. The committee also reviewed existing reassigned time every two years.
 - c. The paper has provided the necessary process for requesting additional reassigned time.
 - 2. Co-Chair McGrath reported the Mesa College Vice Presidents of Administrative Services and Instruction determine how much reassigned time is available for the campus during the summer prior to the start of each academic year.
 - a. Co-Chair McGrath reported he has been able to save jobs by cutting over \$150k in reassigned time.
 - 3. Some existing reassigned time is currently determined at the district level.
 - 4. Co-Chair Crocitti reported he has had difficulty finding out what distinguishes Discretionary from Non-Discretionary reassigned time.
 - 5. Reassigned time needs to go through Program Review as part of an Integrated Planning & Resource Allocation process required by the Accrediting Commission for Community and Junior Colleges (ACCJC).
 - 6. Bill said Faculty needs to be fairly compensated for their work.
