A. Humanities Institute: (Denise Rogers)

 - 2. Scheduling Balance:
 - a. Co-Chair McGrath reported adding English 101 as a prerequisite for a course would reduce enrollment for the course for a time and increase the need for additional sections of English 101.
 - Enrollment for the course will go back down as students complete the English 101 Prerequisite requirement.
