IV. GUEST: Transfer Center Coordinator Leroy Johnson

A. Mesa College's Latest Transfer Data from the CA Community College Chancellor's Office:

- 1. 432 of 598 Mesa College students who transferred to California State Universities (CSU) System transferred to San Diego State University (SDSU).
- 2. 214 of 309 Mesa College students who transferred to University of California (UC) System transferred to the University of California San Diego (UCSD).
- 3. Approximately 1,350 Mesa College students transfer to four year institutions each year.

B. Associate Degrees for Transfer (ADTs):

- 1. Mesa College has completed 13 ADTs (A Degree with a Guarantee).
- 2. When students complete and ADT, 100% of their General Education courses are completed at a community college.
- 3. Counselor Guillermo Marrujo said our students need to know that completing an ADT guarantees admission to a CSU college, but not necessarily San Diego State University (SDSU).

C. Education Plans:

- 1. Comprehensive: 2 Years
- 2. <u>Abbreviated</u>: 1 2 Semesters
- 3. <u>SB 1456</u>: Requires students to prepare and Education Plan with a Counselor in order to continue to receive enrollment priority.

D. Honors Program/Transfer Alliance Program (TAP):

1. Mesa College Honors Program Co-Chair Leticia Lopez reported the transfer rate to four years institutions for students in the Honors Program is 80%.

E. Transfer Admission Guarantees (TAGs):

- 1. SDSU TAGs do not require a signed agreement.
- 2. UCSD TAGs also include UCSD Links for first year students and veterans and has GPA and income requirements.

 - **A.** Mesa College is applying for its first Hispanic Serving Institution (HIS) Title 5 Grant since receiving status as a HIS.
 - B. What will it look like when Mesa College receives the grant?
 - **C.** Mesa College is also working on the following to fulfill its role as an HIS:
 - 1. Preparing students for gateway English and Math courses transferable to four year institutions.
 - 2. Jill Moreno-Ikari reported she has worked with Marilyn Schenk, Wendy Smith and Tracy Walker in the English Department and Terrie Teegarden in the Math Department.
 - 3. Mesa College is also focusing on Accelerated Courses, Learning Communities (LCOMs) and Student Support Services including the Tutoring Center.
 - 4. Student and Faculty Engagement Center:
 - a. Manuel said Latino students report feeling alone on college campuses.
 - b. Guillermo Marrujo said having centers for Black, Latino, or Veteran students give students the opportunity and a place to engage with other students with similar life experiences.

- **A.** Joint Resolution 14.3.1 Massive Open Online Courses (MOOCs): (J. McLeod & D. Miyoshi) 2nd Reading
 - 1. The resolution was written by Kelly Mayhew based on the findings on the San Diego Community College District (SDCCD) MOOC Task Force and has contributions from SDCCD Continuing Education.
 - 2. Jonathan McLeod said Vice Chancellor Lynne Neault reported students have requested credit for taking MOOCs.

- **B.** Resolution 14.3.2 -In Response to Proposed Changes to New ACCJC Standards for Librarians and Libraries: (Devin Milner) 2nd Reading
 - 1. Devin reported the ACCJC is attempting to reduce the roles of Librarians and Libraries.
 - 2. The ACCJC ignored the recommendations of the Counsel of Librarians.
 - 3. The ACCJC is also not listening to the Academic Senate for CA Community College (ASCCC).
 - 4. The 2002 standards correctly reflect the roles of Librarians and Libraries.
 - 5. Jonathan McLeod suggested that the San Diego Community College District (SDCCD) responds collectively and suggests that we speak to Chancellor Carroll who knows the ACCJC well.
- 6. Devin reported the resolution does have the support of San Diego Mesa College President Luster. Motion to approve:
