- B. Resolution American Federation of Teachers (AFT) Accrediting Commission for Community and Junior Colleges (ACCJC): (Jennifer Cost and Lupe Gonzalez)
 - 1 The AFT is seeking support from our local Academic Senates for the resolution regarding ACCJC.
 - 2. The US Department of Education is reviewing ACCJC this Fall.

- 3. The AFT wants to pass this resolution to ensure that the US Department of Education, which has oversight authority over the ACCJC, is made aware of our continuing concerns regarding the ACCJC and its abuses of power.
 - a. The ACCJC has sanctioned its colleges at an alarming rate compared to the other accrediting agencies and continually treats its colleges in an intimidating and punitive manner.
 - It is threatening to remove accreditation from San Francisco Community College.
 - b. Faculty is <u>not</u> being fairly represented on ACCJC review teams.
 - AACJC is non-compliant on this issue by being extremely heavy on Administrator representation.
 - c. Conflict of Interest:
 - ACCJC's leader has placed her spouse in positions on the ACCJC that create Conflicts of Interest.
