#### VI. ROUND TABLE:

San Diego Community College Dist. (SDCCD) Shared Governance Event: (10 Minutes)
The SDCCD held a district wide Shared Governance event on October 11<sup>th</sup> at the University of San Diego with guest State Community Colleges Chancellor Dr. Bryce Harris.

- **A.** Chris Dawes reported that he sees the event as all about Accreditation.
  - 1. The SDCCD compared how each sister college's goals match up with SDCCD's goals and how SDCCD's goals match up with the State's goals through mapping in TaskStream.
    - a. SDCCD's goals do not seem to map up to the state's goals.
  - 2. Chris reported he asked State Chancellor Harris why the Accreditation Commission for Community and Junior Colleges (ACCJC) does not participate in the Shared Governance Process, but did not receive a response.
    - a. Jonathan McLeod reported State Chancellor Harris has to be very careful because the ACCJC has placed San Francisco Community College in jeopardy.
- **B.** Academic Senate President Terry Kohlenberg reported that he thinks the district made a good faith effort.
- **C.** Chair of Chairs Jennifer Cost said it was good for everyone to get together and the situational exercises showed that everyone has different ideas about what Shared Governance is.
  - 1. Jennifer also reported that it was frightening to see the number of external pressures the CA Community College Chancellor's office is under—pressures that exist outside of Shared Governance.
- **D.** Counselor Guillermo Marrujo said it was a great opportunity for everyone to get together, but he does not see any effort for follow-up.
  - a. Guillermo reported that he spoke to Mesa College President Pam Luster about the reduction of student access and he asked her if Mesa College is doing anything to increase access for our students.

# **VIII. NEW BUSINESS:**

A. Curriculum and Instructional Council (CIC) Draft Guidelines & Procedures Changes – For Senate Approval: (Michelle "Toni" Parsons)

The documents needed to be stream lined and updated to reflect the current Title 5 Language:

- 1. Document #1 "AP 5025 Philosophy and Criteria for Associate Degree General Education":
  - a. The CIC approves all requests for General Education Courses from Mesa, City, and Miramar Colleges for the current academic year during the same meeting each year.

- 2. Document #2 "AP Degree and Certificate Development" For Program Approval:
  - a. Process for Program Development and Approval.
  - b. Phyllis Meckstroth and Val Ontell asked where the process was moved to.
    - Toni reported the process was moved to the General Education document.
  - c. Manuel Velez asked about the 10 types of awards that are listed in the document.
    - Toni reported items ii and iv are Associate Degrees and items iii and iv are Transfers.
    - Counselor Guillermo Marrujo reported it was only Arts or Science Degrees before.
    - Jonathan McLeod reported there are problems with Associate Degrees for Transfer (ADTs)/Transfer Model Curriculums (TMCs).
  - b. The Senators recommended changes to the document.

# 3. Document #3 – "Graduation Requirements for Degrees":

- a. Manuel Velez said the document does not make it clear that students must have at least 60 units for an Associate Degree for Transfer (ADT).
  - Counselor Guillermo Marrujo said the document make it sound like students can transfer with less than 60 units.
  - Counselor Lupe Gonzalez said students must have at least 60 units to transfer.
- b. Joe McKenzie expressed concerned about the 12 unit requirement in Residency.
  - Inna Kanevsky said she does not feel it is a hardship for students since 12 units is only one fulltime semester of classes.
- c. There was a sense of the Senate to postpone a vote on the document until Toni can bring Mesa College Academic Senate's suggestions for changes to the CIC meeting on November 13, 2013.
- 4. Document #4 "Prerequisites Assignments Title 5 Changes":
  - a. The CIC developed a Flow Chart for the Cross-Disciplinary Prerequisite Establishment Process.
  - b. Current English and Math Advisories do not require students to take the courses.
  - c. Departments can now request Cross-Disciplinary Prerequisite for their courses with strict guidelines for submitting data to substantiate the necessity for the Cross-Disciplinary Prerequisite requirement.
  - d. Toni reported student representatives always attend the same Curriculum and Plenary workshops that she does on Prerequisites.
    - Katie Holton reported the Statewide Student Senate has data on what students think about Prerequisites.
    - ASG representative Mayra Preciado will check and find out how Mesa College Students feel about Prerequisite requirements.
  - c. There was a sense of the Senate to continue the discussion at the November 4<sup>th</sup> meeting.
