- **I.** CALL TO ORDER, WELCOME, and introduction of the Senate Exec Committee by Academic Senate President Madeleine Hinkes @ 2:19PM.

- A. Associated Student Govt. (ASG) Representative: (President Roberto Rosas) No Report
- **B.** Classified Senate Representative: (President Angela Liewen)
 - 1. Angela reported Vice President McGrath will present a report on how the next phase of Prop. S & N campus building construction will impact foot and vehicle traffic flow on campus at the next Classified Senate meeting and invited the Senators to attend.

- IV. GUESTS: Dean Ashanti Hands and Sergeant Diana Medero: (District Policy 3100 Disruptive Students)
 - A. Dean Hands has sent an email to all Mesa College Faculty this semester regarding District Policy 3100.
 - 1. We have a process in place for the immediate removal of disruptive students from classrooms.
 - a. Dean Hands said it is important to address a problem with a disruptive student right away.
 - Please contact College Police Dispatch for assistance at (619) 388-6405.
 - * Sergeant Medero informed the Senators that an officer will interview the student to find out if the student needs to be referred for assistance and needed services.
 - Please teach your students how to use the red call boxes that are in each classroom.
 - * One of your students can contact College Police if you can't when a problem arises.
 - b. You must tell the student why they are being removed and that they must meet with Dean Hands.
 - Use the first class meeting to set the tone and inform your students about behavior that you deem disruptive and could result in their removal from the classroom.
 - c. An immediate response to a disruptive student usually prevents a first time offender from repeating the disruptive behavior.
 - d. There are webinars available to help Faculty learn how to deal with disruptive students.
 - e. There are also PowerPoint presentations available to assist Faculty with the issue.

- f. Issues that involve violations of Policy 3100 are confidential matters.

 - 1. <u>Board of Governors (BOG)</u>:
 - a. Madeleine reported the BOG has written a resolution that fully supports Prop. 30 (Governor Brown's Tax Initiative). (Our District's Board of Trustees (BOT) and the Academic Senate for CA Community Colleges (ASCCC) also endorse Prop. 30.)
 - Faculty may inform their students about what the passage of Prop. 30 would mean for education in California.
 - * However, Faculty cannot try to influence their students' votes because students are beholden to Faculty for their grades creating a conflict of interest.

- A. Academic Affairs: (Co-Chair John Crocitti)
 - 1. The following subcommittees provided reports on their 2011–2012 activities to the Academic Affairs committee on April 30, 2012:
 - a. Asian Pacific American Studies Committee:
 - The committee requested and received Mesa College student data for Asian Pacific American (APA) students from 2006-2010.
 - The committee awarded one \$300 scholarship.
 - The committee held "Asian Pacific Islander Heritage Week" events in April.
 - The committee reviewed and will continue to reevaluate its mission.
 - b. Global Awareness Committee:
 - The committee has resurrected the Study Abroad Program on campus.
 - The committee is working on Global Awareness Student Learning Outcomes (SLOs).
 - The committee held "International Education Week" events last Fall.
 - * The fees from 30 vendors helped sponsor the committee's scholarships.
 - The committee applied for a Fulbright Scholarship.
 - * Shannon Shi reported their application has been rejected.
 - c. Honors Committee:
 - Honors Contracts Awarded: (Fall 2011 320) (Spring 2012 228)
 - Honors Program Faculty would like to see more Honors Contracts approved for students from under-represented groups.
 - The Honors Club is the largest student club on campus.
 - d. John will continue to report on the activities of Academic Affairs subcommittees during the Fall semester.
