- 1. Academic Senate for CA Community Colleges (ASCCC):
 - a. Cynthia Rico was elected the new Area D Representative by an overwhelming margin.
- 2. Accreditation Midterm Report Forum: April 24, 2013 in LRC 435 from 4:00PM-6:00PM.
- 3. American Federation of Teachers (AFT) Collective Bargaining Agreement (CBA) Proposal:
 - a. AFT is requesting additional reassigned time for Academic Senate officers.
- 4. Budget Allocation Resource Committee (BARC):
 - a. BARC has prioritized the equipment request list.
 - There is \$100K available.
 - President Luster will make the final decision.

A. Miramar College Resolution in Support of Amending the Waiting Period to Retake Assessment and Placement Tests: 3rd Reading

- 1. Guillermo Marrujo said the Counselors still need additional information.
 - a. Terrie Teegarden is willing to meet with the Counselors to explain the process for MATH.
- 2. Terrie Teegarden indicated that students often need to take a math class here, even if they already took it in high school.
- 3. Terrie said the math department has a challenge process and the review courses which allow student to correct their placement level after doing some review.
 - a. This process is a better way to place students than the current placement test.
 - Both the Miramar and City Math departments have agreed that they prefer this way of placing students.

B. Campus Safety:

- 1. Becca Arnold gave an update of recent Faculty/Staff Advisory Committee on Threats (FACTs) recommendations.
 - a. There is already a zero tolerance policy for threatening behavior written into the bargaining agreement
 - Their new proposal will make minor changes to that provision and also add a provision for the formation of threat assessment teams.
 - b. The committee met with the Crisis Response Committee and has a meeting scheduled with the President.

- a. The Senators would like to find out if safety training can be available during the Fall and Spring convocations.
- b. Madeleine will also find out if defibrillator training is available for Faculty.
