VI. Senate Exec Committee Reports:

- **A. President-Elect**: (Terry Kohlenberg)
 - 1. Terry put a call out for volunteers to fill Georgia Laris' vacated position on the Mesa College Foundation.

 - 1. Georgia recommends that Val Ontell replaces her as the Faculty Mesa College Foundation representative.

 - 1. SDCCD Board of Trustees (BOT):
 - a. The SDCCD presented its preliminary budget to the Board of Trustees on April 4th.
 - b. Governor Brown will have a budget update in May.
 - c. The SDCCD BOT needs to submit a tentative budget to the state by June 15th
 - d. The SDCCD passed a resolution in support of Immigration Reform.
 - e. At the urging of Trustee Maria Senor, a panel gave a presentation on Mental Health issues.
 - President Luster and Dean Hands represented Mesa and discussed the need to identify students who need assistance and connect with them.

- b. The District is also looking for a new Mesa College Vice President of Administrative Services and a new Dean of Business and Technology to replace Dean Jill Baker after her transfer to Planning & Institutional Effectiveness.

 - a. The District Human Resources Benefits Office is holding a workshop tomorrow in LRC 435.

- 5. Summer 2013:
 - a. Madeleine reported there are 47 classes totaling 9 FTE for Summer 2013.
 - b. We may be able to offer a regular Summer 2014 session, if Governor Brown's May budget report numbers are good and our district receives additional funding.
 - c. Madeleine will check with Vice Chancellor Lynn Neault regarding contacting students who are on wait-lists for English and Math classes that are being offered this Summer.

 - a. Madeleine reported she attended the dinner on campus on Friday evening.
 - President Luster sponsored the dinner.
 - Faculty and their families were in attendance as well as their deans.

 - a. We want to reach out first and ask for a productive dialogue before decisions are made.
 - b. Rob Fremland reported Departments Chairs are told that they must make decisions immediately and are never afforded the time necessary to consult with Faculty in their departments.
 - We can show administration by passing the resolution that this issue has been an ongoing concern, the next time Faculty and Faculty Leadership are not consulted on an important issue.
 - c. Jennifer Cost feels the resolution is appropriate and the timing is good.
 - d. -Georgia Laris said that Faculty has been completely out of the loop in the decision-making process ever since the Chair of Chairs was disinvited from attending the weekly the Deans' Council meetings.

- A. Report on Joint SDCCD/San Diego Unified Meeting March 19, 2013: (Madeleine Hinkes)
 - 1. Adoption of Common Core Standards:
 - a. Common Core is more interrogatory and challenging for students, and includes Critical Thinking and Writing.
 - It will make sure our high school students know what they need to know.
 - b. Common Core has been adopted in 45 other states and it seems to be working.
 - c. It starts in 1st grade and students are assessed in 11th grade.
 - Students can start taking college classes after they pass the 11th grade assessment.
 - d. Prop. 30 funding may become available for Common Core training for teachers.

1. Madeleine sent a report on the March 30, 2013 Area D meeting to Faculty.

- 2. Becca Arnold said the Contract Faculty positions that will be vacant Fall 2013 need to be filled right away.
 - a. The District also needs to lift the "Hiring Freeze" and fill the current Contract Faculty vacancies.
