Part A: In this section, please analyze your program in terms of course success metric. Start by disaggregating the available data by race, gender, and any other parameters of interest to your program and answer the following questions.

(REQUIRED) A1. What patterns do you notice with regard to equity in course success at the program level by race/ethnicity?

You may also conduct analysis by course and/or by modality.

Equity Gap: When a group of students who share a common characteristic (e.g. race/ethnicity) have lower access and/or outcome rates than their peers. The size of the equity gap along with the size of the group determine whether that gap is significant. Larger groups should, statistically, have smaller gaps and therefore when gaps are present (even small ones) they may be significant. Smaller groups will see wider variation in outcomes, therefore gaps should be seen consistently over time and/or reviewed by looking at multiple years in aggregate to determine if they are significant.

In each of our courses, success rates range from between 73% and 81%. For African Americans, success rates vary dramatically, with a low of 55% for POLI 101 and a range of 66% to 71% for the other courses. For Latinx, the success rate is also lower for POLI 101, and ranges from 71% to 74% for the other classes. For Asians, POLI 103 has much lower success rates, at 54% while the other courses range from 71% to 80%.

Predictably, for African Americans and Latinx, the equity gap is 9% for both, and it is 6% for Pacific Islanders. (We have very few Pacific Islanders in our classes, so the numbers are probably not significant. For example, none have enrolled in POLI 103.) Asians do better by 7% and whites do better by 5%.

(REQUIRED) A2. Do these patterns persist over time (e.g., look at the last five years)? Describe if equity gaps are increasing, decreasing, or staying the same?

In our program overall, success rates have trended up, from 61% to 70%. For Latinx students, this upward trend holds, both for men (56% to 60%) and women (55% to 64%). However, for African American students, we have seen a downward trend for men (67% to 51%), while for women success has increased (46% to 52%).

These trends correspond to a varying equity gap for African American students that ranges from -1 in spring 15, to -6 in spring 17, and -3 in spring 19. Also, for Latinx students, there is no clear trend, ranging from -7 in spring 15 to -5 in spring 17, and -6 in spring 19.

So, the equity gaps for African American and Latinx students do not show a clear trend.

(REQUIRED) A3. What factors may have influenced these results? What are your most significant findings?

One observation one could make is that while outcomes for Latinx students have increased, the equity gap has not, and this suggests that white student outcomes are also increasing over this period. We hope that the success rate for Latinx has increased because of our efforts to reach out to students more consistently and to incorporate more examples of Latinx communities in our readings. We expect that the College's efforts overall have contributed. But we are disappointed that the success rate for African American students has trended downward. Another interesting finding is the dismal performance of underserved groups in our POLI 101 class.

(REQUIRED) A4. How have you/might you alter practices to increase student success and reduce equity gaps?

In the past, faculty members have taken advantage of training sessions (like workshops on microagressions and Teaching Men of Color), the course redesign institute, and other measures in order to specifically focus on equity. We think these efforts have contributed to the increased success of Latinx students, but we plan to continue our efforts to increase the success rate of African American students.

Our focus in the next couple of years includes three main parts: a) working with new adjuncts to ensure attention to equity, 2) introducing new initiatives intended to increase student connection to careers and to transfer institutions, and 3) modifying our approach to teaching POLI 101. First, almost all of our adjunct teachers are new this year or last year so we have been discussing the importance of equity and sharing resources about this issue with them. We held a meeting of new teachers in the Fall and plan to hold another this semester in which this issue, among others, is discussed. Second, in other places in this program review, we have mentioned several initiatives we are working on that target underserved students. One of these is to offer our students the opportunity to participate in the statewide "Pathway to Law School Initiative." This is an attempt to increase diversity in the legal field by providing a curriculum and administrative support that helps community college students get accepted to participating law schools in the state. We hope our school is selected, but even if we are not, we plan to continue efforts like this. For example, we are currently planning a "Law Day" event this spring in conjunction with the San Diego District Attorney's office. We have also been working with students in a Women and Law Club to support students interested in this path. Another initiative one of our faculty have undertaken is to serve as PI on a \$40,000 grant from the American Political Science Association with the purpose of increasing collaboration between 2 yr and 4yr programs on pedagogy. We tailored our grant to request money to develop a "Bridge program" which will provide underserved students with the support they need to successfully transfer as political science majors. We will be developing this material over the coming year and plan to have it in place the following year. This will give us a stronger framework for creating

connections among students and ensuring their success when they leave here. 3) We have also been rethinking our POLI 101 course. Until recently, it has been a required course for those majoring in political science, but we have removed it from the list of required courses. Traditionally, it has been a course that includes two very different groups: student who are totally new to political science, and students who have completed all their other major requirements and then realize they have to also do this standard "introduction" course. Anecdotally, it seems clear that most of our majors enter our program via POLI 102 rather than POLI 101. So, beginning students have been sidelined as the more advanced students drive the class context. As a teacher, I have experienced this. In response, we have sort of demoted POLI 101 to a non-required course so that students who truly wish for an introduction can get it, and students who do not need an introduction won't be required to take it. We feel that this will increase success rates in the course. We have replaced POLI 101 with a new course called "American Political Development" which will also incorporate more material about the ways in which various groups in society have contributed to the building of our political institutions. For example, the course will have a section on the 1619 initiative about the beginning of slavery and its myriad impacts on today's world.

(REQUIRED) A5. How does your program contribute to the College's identity of being a Hispanic Serving Institution?

About 40% of the students who take our courses are Latinx, so they are a central part of our program. And we see our role in teaching about the political system as crucially including the role of this important group. Many of our students share stories of their immigrant experiences with our classes and this enhances our program enormously. It's a terrific teaching tool. And many of our top students were motivated by this aspect of their experience to become political science majors, some targetting law school and careers as immigration attorneys or judges.

We have added a goal for this need.

(REQUIRED) B1. How have you developed this focus? Are you seeing any results? What are your next steps?

We have worked very hard on the various areas of focus we specified last year, and we have begun to see some results.

- 1) We added courses to our program, but we have not yet been able to schedule them due to declining enrollment and the scarcity of adjuncts.
- 2) We won approval for a course sequence that will satisfy the CSU American Institutions requirement specifically one of the new courses (POLI 121) will provide our program with a 2-course sequence that will satisfy this requirement.
- 3) We are working with other colleges in our district to improve communication and coordination of our programs- in the past couple of years, faculty at our college have met several times with counterparts at City and Miramar and have worked together to develop new courses and discuss articulation and scheduling. And we are also working with faculty at local 4 year institutions and other community colleges. One faculty member is a PI on a \$40,000 grant from the American Political Science Association to increase this collaboration and help our students transfer more seamlessly to political science majors.
- 4) We have had limited flexibility to experiment with scheduling to increase enrollment. We added week online courses that filled well.
- 5) We reworked our AA degrees to make them more streamlined and integrated with the UCs and CSUs. We are currently proofing these changes in the catalogue. All changes will be ready for the Fall semester.
- 6) We have been having a hard time recruiting adjunct faculty.
- 7) We are continuing to find ways to reach out to struggling students.
- 8) We are continuing to find ways to make earlier and more consistent contact with students who wish to major in political science. Last semester we developed a survey to deliver in our classes to make contact with these students and plan to continue this in the future. We also began to develop a collection of materials from transfer institutions to enable us to mentor our students more effectively.
