Guided Majors and Mapping Workgroup: Charge of the Committee/Mission Statement DRAFT

The Guided Majors and Mapping Workgroup will:

1. Identify and explore mapping frameworks; seek input on these frameworks from the wider campus community (Academic and Counseling Faculty); develop a framework for implementation at Mesa College; make recommendations to the Mesa Pathways Committee (MPC) [GP Pillars 1, 2, 3],
 - i. Outcome 1a is a finalized “Reviewer Recommendation Form” that has been reviewed and approved by all interested parties. End of Spring 2020.
 - ii. Outcome 1b is to make recommendations to the MPC about what will happen with the maps and how they will be made accessible to students once they are collected. End of Spring 2020.
 - iii. Outcome 1c is to develop a framework for implementation at Mesa College to recommend to the MPC. End of Spring 2020.
2. Identify and explore frameworks for Meta-Major/Areas of Interest/Academic Concentration/Student Goals/Name TBD; seek input on these frameworks from the wider campus community (Academic and Counseling Faculty, Career Center); develop a framework for implementation at Mesa College; make recommendations to the Mesa Pathways Committee (MPC) [GP Pillars 1, 2].
 - i. Outcome 2a will consist of presenting options and receiving feedback from all interested parties. The primary vehicles for this will be the Mesa Mixers, presentations at the Academic Senate, Classified Senate, Associated Students, Chair of Chairs, Deans’ Council, Admin Council, PCAB, and a Flex activity. Start of Fall 2020.
 - ii. Outcome 2b is a well-defined Framework that has been reviewed and approved by all interested parties. This outcome will be completed by the end of Fall 2020.
 - iii. Deadlines for implementation will be determined by the end of Fall 2020.
3. Identify and explore frameworks for a Faculty Advising/Mentoring/Career Advising/Guidance Program/Faculty Support Agent/Name TBD; seek input on these frameworks from the wider campus community (Academic and Counseling Faculty); develop a framework for implementation at Mesa

College; make recommendations to the Mesa Pathways Committee (MPC)
[All GP Pillars]

- i. Outcome 3a is a proposal for this program with a well-defined framework that has been reviewed by all interested parties, including the Academic Senate, Classified Senate, Associated Students, Chair of Chairs, Deans' Council, Admin Council, and PCAB. End of Spring 2021.
 - ii. Outcome 3b is implementation of this program. Due to the likely impact of this program on Faculty workload, elements of it will need to be negotiated by the District and the AFT before such a program can be implemented. It is unclear how long this would take and this work is beyond the purview of this Workgroup.
4. Identify systems of checks and balances through existing or new campus structures to ensure transparency and that these frameworks do no harmⁱ to programs, faculty, staff, or students. Ongoing.
5. Report on work and seek input and guidance from the MPC on items (1), (2), (3), and (4) above. Ongoing.
6. Based on recommendations from the MPC, work to implement the frameworks identified in (1), (2), (3), and (4) above. Ongoing.
