Complete applications are reviewed by the committee in the order received. Partial applications will not be considered. Allow up to 5 weeks for application review before contacting Admissions.

- ARRANGE I-20 Form DELIVERY (See I-20 Form Processing Information)**
 - Students outside of the US must follow the mandatory express mailing instructions. (You will receive a tracking number for your acceptance packet which includes your I-20 Form)
 - Students in the US also have the option to receive a tracking number by using the express mail option below. Otherwise your I-20 Form will be either mailed via standard US mail without a tracking number or available for pickup upon notification of your acceptance.

EXPRESS MAILING INSTRUCTIONS:

Your I-20 Form will be sent through express mail at your expense to guarantee delivery with a tracking number. You must use a credit card (Visa, American Express, MasterCard, or Discover, only) to pay for the express mail service.

Please follow these instructions to complete the process:

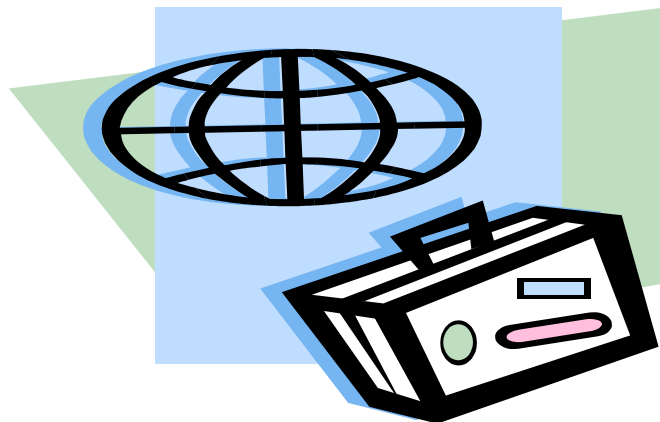
1. Sign up on the [University Express Mail Services website](https://study.eshipglobal.com/) at <https://study.eshipglobal.com/> to have your I-20 Form sent to you. All communication regarding the mailing will be sent from the eShipGlobal service.

On the website, create an account using:

- ✓ the applicant's name
- ✓ applicant's date of birth
- ✓ address line 1 for mailing address for receiving I-20 Form
- ✓ phone number
- ✓ credit card information

*Please pay close attention to the information submitted. Errors in the credit card information or submitting an incorrect or incomplete address could delay the mailing of your I-20 Form.

2. Once you purchase the express mail service, the Mesa College International Student Office will automatically be notified and will schedule a time for your I-20 Form to be mailed to you. As stated on the [eShipGlobal website](#), you will receive your I-20 Form in five business days.
3. If processing I-20 Form from outside US – Schedule F-1 student visa appointment with US Embassy/Consulate.
4. Pay SEVIS fee online.
5. Arrive in time to attend mandatory 4-day orientation approximately 3 weeks before semester.
6. If applying from within US – Notify current institution to request SEVIS release if transferring in active F-1 status.
7. If changing to F1 visa status from other visa type, submit Change of Status approval.
