Include any additional documentation (i.e., medical bills, hospitalization records, accident reports, etc) that supports your explanation.
4. Your application for financial aid will not be considered until you have submitted this form complete and with all required supporting documentation. Please make sure to include your CS ID# at the top of each page or document you submit.
