Information

- * J. Estep noted the updated CRC membership list for Fall 2025 now has A. Malinis from Counseling as the replacement for A. Dines and C. Renda from Allied Health as the replacement for A. Johnston. The updated list is posted on the <u>CRC website</u>.
- * District CIC noted the TMCs are available for the upcoming Mathematics 2.0 and Physics 2.0 revisions which need to be done by Fall 2026.
- * The Meta Steering Committee is resuming.
- * The Academic Senate discussed a new resolution to support work-based learning which will be voted on at a future Senate meeting.
- * The Mesa Catalog Committee will meet on Tues 10/28/2025 via Zoom. The 2026-2027 Catalog proof is now available and will be shared with Chairs and Deans soon.
- * There were no reports from the Policies and Procedures Committee or Program Review Steering Committee (PRSC).
- * N. Resch reported the Mesa Committee of Chairs met and Professional Advancement Committee (PAC) chair Danica Moore gave a presentation to chairs on the PAC process and support available for faculty and chairs. PAC accepts scanned documents with physical signatures in addition to electronic signatures/copies. Danica's office hours are Fridays 1-3 in MS 415Q or via zoom. Communications chair Veronica Gerace is coordinating an effort to create a Department Chair's Handbook. One of the sub-committees would include curriculum related responsibilities of a chair. Committee of Chairs meetings are scheduled twice a month and are only required to meet once per month. One suggestion was to use a second meeting as a working meeting for the department chair's handbook work.
- * A. Hedekin informed the committee three Liberal Arts & Science degrees are being created this semester: 1) Social and Behavioral Studies; 2) Art, Design, and Performance, and 3) Science Studies.
- * J. Estep reported on AB 1111. He reported that most Phase III surveys were due September 29, 2025. A. Reyes-Avila from District CIC has sent invitations for Phase IIB meetings.
- * J. Estep reported that Mesa has sent its response regarding Outcomes to ACCJC on September 22, 2025 and that the ACCJC visit will happen on October 27, 2025.
- * The IDEAA remains on the agenda as a reminder for inclusion of IDEAA in courses, with training, and more discussion in Spring 2026.
- * J. Estep presented the AP changes and minor adjustments were noted.
- * MSC L. Tran/C. Kinney to approve all of the AP proposals.
- * The BP changes were also presented and discussed.
- * MSC M. Cox/J. Bernal to approval all of the BP proposals.

- * J. Estep outlined the three main options for satisfactory completion of GE:
 - "C" grade required for all coursework,
 - "2.0 GPA" for all coursework,
 - minimum "C" for the Areas 1A, 1B, and 2 (English Composition, Critical Thinking and Composition and Mathematical Concepts and Quantitative Reasoning) and 2.0 GPA for the others.
- * A vote on these options will take place at the October 16, 2025 CRC meeting.
- * The COMM C1000 revote was discussed.
- * MSC C. Kinney/N. Resch to reaffirm Mesa's original vote of approval for COMM C1000 with a comment that the original vote was with awareness of the 6,000-word writing requirement. (1 abstention)
