- * A. Dines noted the aligned FILI 100 course needs to be revised prior to Fall 2025 to be approved for Ethnic Studies.
- * The District GE Task Force met on Friday, September 27, 2024 with the next meeting being on Friday, October 11 at 9am via Zoom. The GE Task Force now has three chairs. Please contact J. Estep if interested in being on the GE Task Force.
- * The list of Cal-GETC ADTs is now at CIC.
- * The LAS Degrees continue to be looked at to see what is best for students.
- * Discussion of STEM Calculus & AB 1705 continues and there is another meeting October 4, 2024.
- * District is working on the templates for the AB 1111 courses for the college CRCs to approve. District will input the new courses into COCI and update all of the impacted programs with College approval.
- * What to call Outcomes/Objectives for courses is being discussed; outcomes are not aligned - currently outcomes are being added as an attachment to Mesa's proposals as needed; training of chairs and others to update and utilize them when doing assessments; Stored in META and Nuventive programs – should they go from Meta to Nuventive or from Nuventive to Meta – how often? – when? Discussion of short term versus long term solutions.
- * The incorporation of **IDEAA** (Inclusion, Diversity, Equity, Anti-Racism and Accessibility) into outlines and training will be discussed in November.
