Agenda

- * MSC N. Resch/C. Kinney to approve the December 4, 2025 agenda with the following adjustments:
 - Add Item 4.3 – MATH ADT Deactivation and 4.4 PHYS ADT Deactivation, both with walk-in to CIC. Also add walk-in to CIC to Items 4.1 and 4.2.
- * There are no Minutes from November 21, 2025 so they will be approved along with December 4, 2025 minutes at the 1st Mesa CRC meeting in Spring 2026.

Information

- * There are materials available regarding the new Accounting Method. Victor DeVore has created a dashboard that shows FTEF under different methods including the new Accounting Method. With the new Accounting Method, courses will be compensated the same based on units, regardless of term length and whether offered in person or online.
- * There was a discussion about adding Academic and Career Paths (ACPs) to degrees in Meta. This needs further discussion since Mesa College has degrees in more than one area so this presents a potential challenge.
- * All pending resolutions passed at Mesa Academic Senate including: Ed Plan Codes, Constitution changes to add an adjunct to the Senate executive committee, Program Review Chair must be tenured, and the Senate Vote of No Confidence. There are also new resolutions relating to technology and AI.
- * The Mesa Catalog Committee meets next Tues. 12/9/25 at 3 pm via Zoom.
- * There is no new report regarding the status of the Physical Therapist Assistant (PTA). I. O'Connor reported that there is interest in revising the legislation to remove duplication from the process.
- * Mesa Committee of Chairs meets next Wed. 12/10, and District Policies and Procedures meets on Th 12/11. It's believed that Program Review meets tomorrow. Committee on Outcomes and Assessment (COA) voted on Mon 12/1 to make the outcomes assessment cycle 6 years.
- * J. Parker reported that the NAIS courses and FIL100 are being resubmitted for Ethnic Studies approval. She also reported that there is no requirement currently to do ADTs in any of the Ethnic Studies areas. Mesa is interested in the CHIC ADT, but only one college in California has a course that is required on the TMC.
- * There is a desire to keep lifelong learning in the District GE pattern. A process to involve the other colleges is being discussed.
- * C. Kinney reported that the final two new Liberal Arts & Science Degrees are almost complete with a goal to launch them before close of Fall 2025.
- * J. Bernal reported that M55 won't be included on the STEM flow chart, and the updated flow chart hasn't been finalized.
- * I. O'Connor reported that the templates for Phase III may be delayed. Phase IIB have a required start date of Fall 2027.
- * J. Estep reported that the CRC Co-Chair elections are to be completed in March 2026.

- * There will be COR and IDEAA training in Spring 2026. All courses have to be entered manually into COCI no later than 2030 to be in compliance (currently the COR can be attached as a document).
- * There are some challenges with credit by exam. Currently, to have agreements with Continuing Education or High School courses, credit by exam must be allowable.
