As reported by Mary Gwin:

"Mary Gwin reported on the Administration's decision not to include the AS Senate, Classified Senate, or Associated Student Government in the Administration offices in the new building. This seems like a missed opportunity for participatory governance. Mary also reported that our Vice President of Administrative Services attempted to schedule a meeting with her, Sim Barhoun, and Andrew Hoffman to talk Measure HH and the construction of the English Building, but has not responded to emails to schedule the meeting or answer questions. Mary also reported on the failure to repair the damage from the LRC's fourth-floor sewer system clog. The clog caused an overflow of water that affected the 4th floor and leaked through the 3rd floor ceiling. An emergency was declared on July 11, 2025. The total cost estimate was \$252,945; the completion estimate was originally the end of August, then it was updated to the last week of September. It is now the middle of October. Finally, after the tragic event that occurred on our campus in April 2024, there is no apparent emergency plan in place."

Common Course Numbering - COMM C1000 (Formerly COMS 103 - Oral Communication): Malinis
 As reported by Bryan Malinis:

"Bryan Malinis (Communication Studies) spoke about concerns regarding administrative interference with the curriculum review and approval process. District is asking for a full review of COMM C1000 despite no proposal from faculty at any of the colleges to change the Course Outline of Record (COR). District did not express concerns until enforcement of the 25-student cap per CBA was invoked."

The summaries at the top describe BP 4107 as renumbered, but I cannot find what it was renumbered from.

BP 4050 is formerly 5050 (not 4050). Additionally, I think the description from 4107 was for 4050 (and perhaps the description from 4107 is missing).

I updated formerly 5050; left the description for 4107—we are moving it to the 4000s numbering, and added a description for 4050.

# BP 4107 - HEALTH OCCUPATION INSTRUCTION—USE OF CLINICAL FACILITIES

The Board of Trustees directs the Chancellor to establish procedures ensuring the use of off-campus resources and clinical facilities enhances the career technical educational capability of health occupations instruction when such use aligns with the educational objectives of the San Diego Community College District Colleges . The Chancellor is directed to develop and implement procedures based upon the following standards:

- A fully executed agreement between the District and a clinical facility must be approved by the Board of Trustees and be on file at the District Office prior to assignment of any health occupations program students.
- A clinical facility must be licensed by the State of California to operate as a health care facility.
- The clinical facility must be willing to assist the District in helping to accomplish its educational objectives.

Per APxxxxx, the district shall keep and submit such records and reports concerning approved clinical placement sites.

# III. Associate Degrees.

For the Associate Degree, Associate of Science (AS) or Associate of Arts degree (AA), students must satisfactorily complete at least 60 semester units or 90 quarter units of degree-applicable lower division credit courses, including courses that apply to the major or area of emphasis in career technical fields and courses in composition, reading, and mathematics or quantitative reasoning not more than one level below transfer. Below transfer level course requirements must align with Education Code section 78213.

AP 4100

The courses must include at least 18 semester units in general education and at least 18 semester units or in a major listed in the community college's "Taxonomy of Programs."

Courses completed at other institutionally accredited institutions that meet or exceed the standards of the California Community Colleges will be accepted and counted toward the unit requirements for an associate degree.

Students who intend to transfer shall be advised of limitations transfer institutions may place on the transferability of credits, based on institutional accreditation, course modality, and any other relevant factors.

# II. Associate Degrees for Transfer

To earn an Associate in Arts for Transfer (AA-T) or an Associate in Science for Transfer (AS-T) degree, students must satisfactorily complete the graduation requirements outlined in Title 5 regulations, Senate Bill 1440, and Senate Bill 400.

These transfer degrees are specifically designed for students intending to pursue a baccalaureate degree in a related major at a California State University (CSU). However, acceptance of an AA-T or AS-T degree may vary by CSU campus and major.

#### General Education

Students must successfully complete California General Education Transfer Curriculum (Cal-GETC).

Students who have established and maintained catalog rights may fulfill general education requirements by using an approved intersegmental lower-division general education transfer pattern (e.g., IGETC or CSU GE) that was in effect when they first enrolled at a California community college aligned with their designated catalog year.

Grade Point Average (GPA) and Minimum Grade Requirements

- Students must earn a grade of "C" or better in courses required for the major. A pass grade, "P", meets this requirement.
- Students must complete the requirements for the baccalaureate degree with a minimum cumulative grade point average of 2.0 in degree applicable courses.

It does the same thing under General Education (baccalaureate degree). (It is not under Associate Degrees - non-transfer.) I updated it, it's a copy paste error

To that point, there seems to be a lot of redundancy in this AP. The 12-unit residency is listed multiple times, including under General Education (I do not understand why it would be listed there). This instance of General Education is a subheading under Associate Degrees. I removed the IV; we listed residency for each type of degree. We separate out ADTs because they have some distinct requirements.

General Education (9

The degree must include at least 21 semester units or 28-31.5 quarter units of general education. One course must be selected from each of the following areas: English Composition; Oral Communication and Critical Thinking; Mathematical Concepts and Quantitative Reasoning; Arts and Humanities; Social and Behavioral Sciences; Natural Sciences; and Ethnic Studies.

This 12-unit residence requirement is effective for all degrees awarded regardless of catalog year.

Courses completed via credit for prior learning, including credit by examination, do not qualify for the 12-unit residence requirement.

The Board may excuse the residence requirement to alleviate injustice or undue hardship.
