As reported by Andrew Hoffman:

"The ASCCC Fall Plenary Session was held November 7-9 in Visalia this time. I think the site was chosen to minimize distractions for the attendees, and there were certainly few distractions! The theme of the plenary was "Cultivating Student Success Through Faculty Engagement, Practice, and Community." In my opinion, however, the underlying theme was all about Artificial Intelligence. I attended the breakout session titled "Impact of AI on Academic Integrity Policies and Syllabus Language" and "Designing Inclusive AI Learning Experiences for Diverse Learners."

As you might expect, there was the full range of experiences and attitudes about AI. Some were near-hacker level, navigating smoothly through AI (not surprisingly, this person was from CalBright, the entirely online college) to the Not-on-My-Watch gang.

I also attended a breakout on the Rising Scholars program (for justice-system impacted students), which I found quite interesting. A number of the instructors at that session were formerly incarcerated persons. I wondered if there were ways we could raise the profile of our own Rising Scholars here at Mesa College.

As for the resolutions:

As at the last plenary, there were resolutions regarding statewide laws recently imposed on the community colleges. One titled "No Implementation without Articulation" calls for a slow down in CCN and advocates for an articulation-first approach before CCN is implemented. A similar one calling for more delay passed unanimously. A third called for using CCN Templates for transfer and Cal-GETC.

Two resolutions calling for the Chancellor's Office to advocate for more help for our STEM students by loosening the interpretation of AB1705 so our students can get the support they need to be successful were both passed by Consent. A third calling to restore student choice passed unanimously.

A resolution calling for more evaluation of AI for faculty use also passed by Consent.

Another resolution of importance particularly to Mesa was the resolution urging that Nutrition to be defined as a science eligible to fulfill Cal-GETC Subject Area 5B was approved.

Some resolutions were defeated. Of particular interest, the resolution proposing to drop Objectives from the COR and replacing them with Outcomes to satisfy Title V was voted down. I was very happy about that. Another resolution calling for ASCCC to put forward course syllabi guidelines was voted down. I opposed it as not being appropriate for the ASCCC, but as something that should be handled at the local level. Also defeated was the resolution calling for automatic approval of Ethnic Studies courses for Cal-GETC. Many ethnic studies faculty spoke against this for fear it would lead to abuse – particularly that courses not truly in ethnic studies areas (Black Studies, Chicano/a Studies, Asian Pacific Islander Studies, Native American Studies) would be approved.

Training was held for FHP on Friday, November 15. The session was well attended both in person and by hybrid. On Monday, Nov. 18, Eliza Rabinovich sent out an email with access to the slides, an IE glossary, other related documents, and a link to the video of Friday's session. Resolution 2024.11.1 - Opposition to the Deployment of Potentially Lethal Tasers San Diego Community College District Campuses: Senator Jennifer Moreno

Mover: Katungi Seconder: Cost

Whereas in 2022, under the leadership of Chancellor, Carlos Cortez, the San Diego Community College District (SDCCD) purchased Conducted Energy Devices (also known as Tasers) to arm SDCCD police officers, spending \$1973 on each Conducted Energy Device (CED) totaling \$78,000. Deployment of tasers may result in recertification costs or periodic inspection and servicing.

Whereas the SDCCD Police Taskforce Subcommittee reviewed over 40 academic studies, none of which were affiliated with law enforcement, CED manufacturers, or relied on anecdotal evidence, and contradicts many of the findings discussed in the report conducted by "Secure Brand Management," a PR company founded in part by a former law enforcement officer, and hired by Vice Chancellor Peterson, that rely heavily on interviews with police and data from CED manufacturers, and excludes essential student and campus community perspectives.

Whereas a 2020 study by *Reuters* on deaths associated with tasers "documented 1,081 cases through the end of 2018 in which people died after being shocked by police with a Taser, the vast majority of them after 2000. At least 32% of those who died were Black, and at least 29% were White. African-Americans make up 14% of the U.S. population, and non Hispanic whites 60%."²

Whereas the SDCCD "Board of Trustees Goals for 2024 -25" states their commitment "to maintaining high levels of student success and well-being, to promoting a community consistent with the values of social and racial justice..."³

Whereas one of the San Diego Community College District's strategic goals in their "Mission and Goals" page is to "Ensure fiscal solvency through sound fiscal planning and management."

Whereas, by adopting the "Resolved" points below, the Board of Trustees would be acting in accordance to the resolution it adopted on June 11, 2020, which states: "The Board of Trustees of the San Diego Community College District denounces systemic racism in all its forms and affirms the District's commitment to Black students and all students of color who have been subject to both overt and passive forms of racism." Further stating that, "the devaluing of Black lives is manifested not just through acts of police violence, but through the systemic violence of oppression and poverty." The current actions of the SDCCD police force to acquire and utilize tasers does not align with the ideas set forth in the above resolution.⁵

Be it resolved that the San Diego Mesa College Academic Senate urges the San Diego

Community College District to uphold its commitment to "student well-being" by opposing the implementation of Conducted

Energy Devices (CED) on San Community College District campuses.

Be it resolved that the San Diego Community College District upholds its commitment to fiscal solvency and prevents

additional spending on CED police training and recertification and instead uses these resources to "Maximize student access,

learning, and success" as outlined in the District's Mission and Strategic goals.
