This plan will also capture the intentionality to supporting disproportionately impacted students based on race. We need to provide information from other campus-wide programs such as Pathways and equity are coming together to support the elimination of equity gaps. The template that will be entered in Nova, asks various questions and only allows for 2500 characters per section. One category needs to be the

focus and the SET Committee with the help of the Research Office will help to identify the disproportionately impacted groups. It was suggested to include the specific objectives that Pathways Committees are leading since Pathways has been identified as the coordinating body.
