We hosted a "Pet Show and Tell!" on Zoom on June 21st where we got to meet the furry friends of Student Services. We also hosted a Pet Choice Awards 2021 Photo Contest with a total of 69 submissions for 5categories! The Mesa Community had the opportunity to vote for their favorite pet photos, and the winners received Amazon gift cards!

  belonging, and to let students know resources are ready for them. A popular activity, the Meet
  and Greet was divided up into two days to allow presenters more time to dialogue with
  CRUISErs.
- Counseling Department equity efforts continue with the addition of offering Cafecito Zoom
  Meetings targeted to Latin@ student who are not in good standing. The first Cafecito hour
  served nine students. During this hour, students meet with two of our "Consejeros" to answer
  immediate questions and to share information on topics such as on- and off- campus resources,
  career paths, review of required courses, Covid 19, and returning to campus.

- EOPS is excited to share that they changed the Project Restart program name to Rising Scholars as of July 2021. Rising Scholars is the program name used by the California Community College Chancellor's Office (CCCCO).
- EOPS is accepting new EOPS student applications for Fall 2021. Please share with students! Eligible students will also receive an invitation to apply through email from the SDCCD district.
- Financial Aid is working alongside other SS Departments in the implementation of the QLess.
- 460 incoming Year 1 Promise students have signed the Promise Contract and are officially
  enrolled in the Promise program. We are working with an additional 450 students to resolve
  application issues and get enrolled in the Promise program.
- Mesa College has been designated as a 2020-2021 Military Friendly School with a Silver Recognition.
- The College Technical Analyst and team launched the "First Steps" newsletter to students who completed online orientation

#### **Student Success Stories**

- Credit the new Peer Navigators who invested over 100 hours on Zoom to support new, incoming students. The team has really come together and shown patience and resiliency in a very small amount of time. We have a great group on our hands!
- About half of CalWORKs spring 2021 students enrolled in summer 2021 classes, even though the
  county was not requiring students to report or complete any activity to continue to receive Cash
  Aid from the county.
- A student in Professor Kirsten Pogue-Cely PG 130 needed immediate financial assistance due to several challenging life factors (newly immigrated to the United States; student was laid off from her retailing job due to the pandemic; and current separation from spouse). Professor Pogue-Cely shared that Mesa was offering relief grants (HEERF) in the spring of 2021. The student applied and was awarded \$750.00 and with that money the student was able to enroll for fall 2021. Professor Pogue-Cely was also able to assist the student in researching a new career path.

#### **Innovations & Data**

For June and July, we replied to 1,847 emails, 1757 phone calls were answered on our Admissions phone tree, and an additional 209 were documented on Google Voice. We are working on a better way to track our Google voice calls. We helped 8 students with their home certification for SDSU cross-enrollment. We supported 47 international students and replied to 258 Residency inquiries. We reviewed 204 summer supplemental applications and enrolled 179 high school students. We also enrolled 158 students into 6 CCAP/ACP summer classes. We processed 598 MySDCCD Support items including name changes, registration worksheets, and grad status changes. We spoke with 60 prospective students and responded to 55 transcripts inquiries. We also completed 85 verification of enrollments.

#### **Policies & Procedures**

• Effective 07/13/2021, the US Department of Education will allow the waiver of any V1 verification documents (IRS Tax Transcripts and Verification Worksheet) for any selected record without conflicting information. Currently this is a monumental tasks with over 1900 eligible files that must be manually evaluated for decision making. SAT-FA staff have been working overtime to review and waive as many applicable documents as possible. IN addition, the Department has allowed the waiver on the Selective Service registration (for federal aid) and on students with drug offenses. California as no objection over the waiver of the verification documents but will require any male student born after 1960 to be in compliance with the Selective Service if, Cal Grant eligible. E- Consent was activated, students must complete the e-consent process in order to receive or exchange any information or communication via electronic means. We have mailed over 1,800 letters to students who have not completed the E-Consent process.

- Along with working on the new electronic health records (EHR), Student Health is reporting to San Diego Regional Immunization Registry (SDIR) to input all COVID vaccine information in this branch website.
- We served 329 students in June and in July we served 371 with medical and mental health needs. We are seeing Athletes and Allied Health students for their in-person health physicals and vaccines.
