#### 7. Discussion Items

#### 1. Commencement Versus Graduation

Iana presented the Guide to Graduation workshop, clarifying that graduation is the process of earning a degree while commencement is an optional ceremony. She explained the steps, including meeting with a counselor, applying for graduation through the student portal, completing all requirements, and then receiving the diploma by mail. Students who have taken classes outside the district must notify evaluators, and counseling is recommended to finalize education plans. Application deadlines are February 15, 2026, for CSU transfers and April 30, 2025, for non-transfers. To have names included in the commencement program, information must be submitted by March 15, 2026. Commencement will be held on May 29, 2026, in the football stadium, and students must RSVP. Guests ages three and older will require tickets, and family members who cannot attend may watch through the live stream. Questions can be emailed to mesaevaluations@sdccd.edu.

### 2. Duties for Hallow Pep Rally

Multiple volunteer positions are needed for set-up, games, and food. All volunteers will receive a designated break to eat, with specific times allotted for these breaks. Allocation of positions for ASG members will take place next week.

3. San Diego Mesa College Foundation and ASG Scholarships
